# Full Participating Salon:

## As a full participating salon, you will receive:

- Listing as a participating salon on HVCS' website, social media outreach, and event promotional pieces
- Mention on in-studio radio promotions & other media sources
- Listing in the event program
- 5 tickets / backstage passes for models and stylists
- 5 Preferred seating tickets for the event (specific details TBD)
- Listing on the Hair Show video screens and throughout the event
- Assistance, if desired, in formulating your concept and crafting a "story" about your work

## As a full participating salon, I/we agree to the following terms:

- We will submit up to (2) models to the Hair Show to display our creativity, skill and ingenuity.
- These looks will be unique and innovative; we will work with the Salon Coordinators to ensure that each salon features a unique, non-repetitive look or concept. I/we will register our concept by May 1, 2016.
- Our looks will fit into the overall show theme set by the Salon Coordinator(s). This year's theme: "Hair Through the Ages"
- A representative from our salon will attend the Participating Salon meetings and rehearsals.
- The models and stylists from our salon are the only crew members allowed backstage at the event.
- We will submit the \$200 participation fee by April 1, 2016. This non-refundable<sup>+</sup> fee guarantees our spot in the show and provides five (5) tickets (in addition to the 5 backstage passes mentioned above).
- We will submit a digital copy of our logo to HVCS for marketing and promotional purposes.
- We will supply HVCS with a list of names allowed backstage (models and stylists) by July 15, 2016.
- We understand that all costs for models, supplies, styling products, costumes, cosmetics and props, etc. are the responsibility of this salon. HVCS, the event venue or the event coordinators are *not* responsible for reimbursement of any expenses related to this event.
